

### Safe Works Manager Recert (SWM) (E-Assessment) - Session (1300hrs)

This course is designed to train individuals to be Safe Work Managers (SWM). A SWM may be identified and appointed in a complex worksite under possession where the complexity of the worksite may require an additional ES to support to maintain effective control of identified risks.

It is recognised that in multi-activity worksites, the workload associated with the Safe Work Pack process (i.e. managing the number of packs), coupled with that of the Rule Book duties of an ES may be excessive leading to an increase in operational and work activity related interface risk. This also includes in DC line areas the additional responsibilities assigned under NR/WI/ELP/3091.

The aim of this course is to provide delegates with the skills and underpinning knowledge required to undertake Safe Work Manager in line with the associated competence.

### Instructions

Intertrain will register the candidate(s) on the Rail Exams website. Please supply candidate(s) e-mail address prior to training.

This is an online invigilated assessment. Candidates are advised to read through the 019 Standard prior to attending.

It is the Sponsors responsibility to ensure candidates booked onto the course are eligible for the training they are to receive and in line with any relevant medical level or restriction that may apply, in accordance with NR/L2/OHS/00124 Competence Specific Fitness Medical Requirements.

Please be aware that candidates will be treated on a training event as if they are at work and they must comply with the relevant medical policy and bring their Sentinel Smartcard which will be swiped at the start of the course.

### Candidates must:-

Be a minimum age of 18.

Hold valid PTS (must not be in Learning Support) and Safe Work Manager competencies.

Have sufficient command of English language as detailed in Network Rail Company Specification NR/S/CTM/021 (Competence & Training in Track Safety)

Meet the medical requirements of Network Rail Standard NR/L2/OHS/00124 Competence Specific Fitness Medical Requirements to minimum medical level 4 and Network Rail Standard NR/L1/OHS/051 (Drugs & Alcohol).

Photo ID - For British Nationals, one of the following (**original hard copy - not electronically**): a current and valid branded form of identity token, used for accessing the RMI (Railway Maintained Infrastructure) such as a Sentinel Card; in-date and valid full driving licence; in-date and valid UK Provisional Photo Card Driving Licence; in-date and valid passport, biometric ID Card, resident permit as per Home Office guidance or 'ValIDate' card.

For Non-British Nationals - an in-date and valid passport is required (**original hard copy - not electronically**).

Proven experience in managing/supervising a complex worksite in a railway environment subject to GE/RT 8000 Rule Book adherence from planning to delivery.

Experience and/or qualification in site risk management.

An understanding of the principles underpinning CDM (Construction Design Management) either through experience or evidence of training.

Approval for SWM training confirming suitability including review of appropriate non-technical skills and evidence of pre-requisites by a Senior Manager.
